# DECLARATION OF GRECIA FIGUEROA

In Support of Request for Civil Harassment Restraining Order

I, Grecia Figueroa, declare as follows:

## A. Who I Am

I am 37 years old, a Peruvian-American journalist and public relations professional. My life's work has been devoted to amplifying voices, telling the truth, and serving with fairness and integrity. As an immigrant and a woman of color, I have built my career through resilience and hard work, navigating public spaces while holding firmly to the belief that facts and voices matter.

I have never before sought a restraining order against anyone. I am doing so now because the respondent's escalating harassment has left me with no other option.

## B. Who Respondent Is

The respondent, Lorena Gonzalez-Fletcher is 54 years old. She is the wife of Nathan Fletcher, a man who pursued me sexually for over a year, resulting in my lawsuit against him for workplace sexual harassment, and whose misconduct is the very reason she now seeks to harm me. **She was neither a defendant in the lawsuit nor a witness to any of the events described in my claims.**

Ms. Gonzalez is also a former elected official, the current leader of the California Labor Federation AFL-CIO, and a licensed attorney.

By virtue of her marriage, she knows exactly who I am and the nature of my lawsuit. By virtue of her age and experience, she knows the weight of her words and the reach of her platform — which exceeds 100,000 followers. While my lawsuit was dismissed on technicalities, (not merit) I'm still in litigation due to my pending appeal and her own husband's lawsuit against me, therefore I can't defend myself publicly. **Yet rather than respecting the truth or legal process, she has chosen to engage in vindictive harassment fueled with lies, misrepresent court rulings, and incite hostility against me.**

## C. Threats Against Me: Ms Gonzalez "WANTS BLOOD" (EXHIBIT A)

On March 26, 2023, just two days before I filed my lawsuit against her husband (and hours before he abandoned his Senate campaign), my attorney was told by Mr. Fletcher's counsel that Ms. Gonzalez said she **"wants blood,"** and would **"go nuclear"** against me. She added that Ms. Gonzalez would **"make her look terrible,"** and intended to **"follow her for the rest of her life"**, referring to me, if I filed my lawsuit against her husband, Nathan Fletcher.

These words were not about legal defense; they were about destruction, meant to terrify me into silence. Despite this, I filed suit on March 28, 2023.

#### D. Overview: Harassment and Obsession

Ms. Gonzalez has engaged in sadistic and malicious harassment against me. Her conduct is not mere commentary; it is an obsessive fixation aimed to disrupt every aspect of my life. Since the inception of my lawsuit, she has posted about me dozens of times, fabricating lies, twisting my words, and degrading me in front of her vast audience- **all with reckless disregard for the truth.**

She is constantly scanning for stories about me or my case, commenting on posts posing as a “fact checker” but spreading lies, **(EXHIBIT C)**. Her stalking and fixation is alarming considering she has a family and a demanding public role, yet she devotes extraordinary time and energy to surveilling, smearing, and persecuting me. **She repeatedly casts herself as the victim in order to manipulate the public's sympathy and incite attacks against me.** Her narrative relies on flipping the truth: accusing me of conduct that she herself initiates over and over again.

I have tried to avoid responding to her in any way precisely because I feared that any reaction might provoke harsher retaliation. But even without any engagement on my part, her conduct has escalated. In the past few weeks alone, she has gone further than ever before, openly **inciting her followers to join in her attacks**, urging them to **monitor me, report on me, and deliver so-called “receipts” for her to weaponize.** **(EXHIBIT B)** This is not commentary. This is incitement. It is the deliberate creation of a hostile mob against me.

Her smear campaign is not only obsessive; it is dangerous. It has moved from words to coordinated hostility, escalating in ways that create a **real and imminent risk of violence.**

#### E. Planned Attacks Through Misogyny and Racism

I've identified talking points Ms. Gonzalez pushes with the help of third parties which mirror a bullet-point defense scheme found on her husband's phone. The sinister plan crafted before I filed suit laid out how they would flip the narrative by having the “situation changed” with instructions to “attack woman” (me) by leaning on **sexist and even racist rhetoric and stereotypes, while highlighting his “struggles.”** *(Document under protective order in related litigation)* (Talking points on **Exhibit B & D**)

Despite neither Fletcher nor his wife speaking Spanish, these same notes pointed to looking for a “Spanish phrase” to disparage me, reducing my identity as a Latina woman to a stereotype for public ridicule. **This was not a defense strategy; it was a calculated scheme to assassinate my character and silence me through misogyny and racism.**

That plan has since been carried out openly by Ms. Gonzalez and her allies, who repeat those demeaning sexist stereotypes in their posts and public statements. And whose comments she publicly thanks them for. **(EXHIBIT D-** Rep. Scott Peters's remarks/ **EXHIBIT E -** Gonzalez's brother's posts/**EXHIBIT F-** Gonzalez Thank you Post)

## **F. Impersonation Accounts:**

To make matters worse, I have reason to believe she is connected to impersonation accounts created to mock and torment me, including one that used my second last name. This last name, a personal detail from confidential documents in litigation, was only available to her husband and the defense lawyers. That impersonation account, which she openly enjoys, **(EXHIBIT H)**, went as far as mocking my trauma and posting that I should “**stay suicidal.**” **(EXHIBIT G)**

**Such disturbing content is not only vile but cruel, sadistic, and abusive, the kind of harassment that shows not opinion but a sick preoccupation with trying to annihilate me.**

## **G. Why I’m Filing A Restraining Order Now**

For a long time, I gave Ms. Gonzalez grace, tried to convince myself that maybe one day she’d act reasonable and see that her attacks were cruel and undeserved. That perhaps she was misinformed, emotional, or truly believed her public statements. But her actions have proven otherwise. **She does not care for the truth.**

This became even more clear when my lawsuit was dismissed on legal technicalities in August 2025 (a ruling I’m in the process of appealing) Rather than acknowledge the ruling for what it was, Ms. Gonzalez twisted it into a lie, telling her large audience that my claims had been proven false and portraying her husband — my aggressor — as the victim. **(EXHIBIT B)**

## **H. News Conference September 12, 2025**

Most recently, Ms. Gonzalez asked her husband to host a news conference. During the event they summoned all news media to further push their narrative and smears. **(EXHIBIT J)**

I anticipate Ms. Gonzalez will try to argue that she is just “defending her husband/family” and her attacks are only “opinions”. But that is not the case. I’m not a public figure, and still she dedicated 70% of her speaking time at the presser to disparaging me and pushing vile lies using her title as an attorney to present them as facts.

Furthermore, when her husband was asked to comment on consent, Ms Gonzalez **INSTRUCTED** him not to answer, and hijacked his response by inserting herself and making sweeping false statements about evidence produced in litigation She is not her counsel. **(EXHIBIT K)**

Even more revealing, in the 2023 pre-litigation email where her threats were memorialized, she claimed she “**wrote half the laws about sexual harassment**” and planning to lean on sexist demeaning remarks to cast a younger woman (me) as the aggressor — a sentiment she repeated almost verbatim at the news conference last Friday: “**I wrote more laws about sexual harassment...**” **(EXHIBIT K)** These are all deliberate, calculated misstatements designed to smear me as dishonest, and manipulate others into acting with hostility against me.

## I. Escalation of Conduct

Every threat from the beginning has been carried out step by step, but since August 2025 the conduct has intensified. She has orchestrated a campaign steeped in cruelty, vitriol, and ruthless intent:

- She has urged her followers to surveil me, openly instructing them to send her “screenshots” of my activity, **turning strangers into spies for her sadistic amusement. (EXHIBIT B, L)**
- She has enlisted political power, going so far as to praise **a Congressman for echoing her fabricated narrative**, magnifying the smear with influence designed to isolate and destroy me. **(EXHIBIT D)**
- She has concocted grotesque lies about me such as propositioning sexual acts, and fabricating allegations. **(EXHIBIT B,F, E)** . Statements designed to humiliate and objectify me in the most degrading way possible.
- She has encouraged and validated followers who have posted threats and expressed wishes of harm, reveling in their attacks as though feeding a mob. **(EXHIBIT B, more evidence available at request of the court)**
- Most chilling of all, she has been tied to impersonation accounts designed to mock the trauma her husband inflicted, including one that urged me to **“stay suicidal.”** This is not ordinary harassment; it is a sadistic obsession, a vicious fixation meant to inflict pain, humiliate, and drive me into despair. **(EXHIBIT G & H)**

Each of these actions shows not only hostility but a **pathological fixation — one that is growing more dangerous over time.**

## J. How I Now Live

- Because of her conduct, my life has been reshaped into constant vigilance and now fear. Knowing that perpetrators often learn patterns, I avoid being predictable in my daily routine and going to public gatherings where I may be confronted or attacked.
- I’m concerned daily that by provoking visceral anger toward me from her followers, she turns me into a target for anyone who may be mentally vulnerable and seeking to “take justice into their own hands.”
- Online, I have been forced to be overly cautious about my presence, my whereabouts, aware that anything I post will be twisted, mocked, or weaponized. She is not only stalking my digital footprint; she is attempting to control how I move through the world.
- She knows where I live, as well as my vehicle information and phone number, leaving me feeling unsafe in the one place I should be safe: my own home.
- Her words — “follow her for the rest of her life” — were not idle. They were aimed to transform my daily life, stripping away peace, safety, and freedom of expression.

## K. Chilling Effect on Others

Her abuse of power and harassment does not just harm me. It sends a message to every survivor and potential witness: **stay silent or be destroyed.**

She knows I can't publicly defend myself due to litigation. This kind of harassment cannot be tolerated because it not only puts my life in jeopardy, it corrodes the very foundation of justice, intimidates witnesses into silence, deters survivors from coming forward, and emboldens the powerful to believe they can retaliate without consequence.

#### **L. Why Court Intervention Is Needed**

I have done everything in my power to stop her harassment. I have ignored her. I have blocked her. On a few occasions, I have even directly asked her to stop, requesting that she respect the legal process. I have approached this situation as any rational, mature, and law-abiding adult would — with restraint, civility, and patience — hoping she might recognize the harm and choose to stop on her own. But she has not stopped. She has only escalated.

I am left with no other course but to ask this Court for help. Without intervention, her conduct will not end. Left unchecked, **it will continue to escalate until words and incitement spill into real-world harm.**

#### **M. Requested Relief**

I respectfully request an order under Code of Civil Procedure § 527.6 restraining Ms. Gonzalez from:

- Contacting me directly or indirectly;
- Tagging, naming, or referencing me online, directly or indirectly;
- Tagging naming, or referencing online any current or potential witness in my lawsuit
- Soliciting or encouraging others to monitor or harass me;
- Creating, operating, or contributing to impersonation accounts;
- Coming within 100 yards of my home, workplace, or events;
- Engaging in surveillance, monitoring, or stalking of any kind;

To archive or remove from public view (without deleting or destroying) all past posts and comments about me.

#### **N. Request for Help:**

I am pleading with this Court for protection. Saying she ***"wants blood"*** or ***"follow her for the rest of her life"*** were not empty phrases; it was a promise, and every other threat since has been carried out in plain view. Now her campaign has escalated into open incitement, unleashing others to stalk and torment me, while she takes pleasure in sadistic ridicule of my trauma — which has gone as far as to encourage suicidal ideation. **This is not commentary. It is not politics. It is harassment — obsessive and dangerous.**

If the Court does not intervene, her words and her incitement will inevitably cross the line into real violence. I am asking, urgently and unequivocally, for this Court to protect me before it is too late.

Danielle,

Thank you for returning my phone call this evening. I just want to memorialize a few things that you shared with me during our conversation today, because I think they may become relevant further down the road:

1. Lorena Gonzalez-Fletcher is now aware of Grecia's accusations (or some version of the story) and is now, for all intents and purposes, steering the defense strategy on behalf of her husband, Nathan Fletcher.
2. Lorena Gonzalez-Fletcher is "mad" at her husband but also mad at Grecia for what happened. She "wants blood," and her intention is to "go nuclear" with a scorched-earth defense strategy if/when we file suit.
3. Lorena Gonzalez-Fletcher's intends to counter-sue Grecia, and me, for extortion if we file our sexual harassment lawsuit against Nathan Fletcher. Or at least, "that's her position." Lorena Gonzalez-Fletcher and Nathan Fletcher intend to "come hard" at Grecia. "They're going to make her look terrible, and it's going to follow her for the rest of her life."
4. Lorena Gonzalez-Fletcher "wrote half the bills" about sexual harassment; but, according to her, "they were not designed to reward a strong 35 year old woman" who "goes after" a man who was "weak" because his wife was having breast cancer surgery.
5. Lorena Gonzalez-Fletcher's version of the story is that Grecia pursued Nathan Fletcher for his "fame and notoriety," and Grecia "put her young boobs in his face" and told him, "you should wear your glasses more often, it looks hot." In other words, Nathan Fletcher was the victim.
6. Lastly, you mentioned that you might be willing to share some authorities to support Lorena Gonzalez' threat of suing my client and/or me for extortion if/when we file the sexual harassment lawsuit. Although I initially declined to see them...upon further reflection, I'd like to see them. Please send me a copy at your earliest convenience.

If I missed or materially misstated anything above, please let me know.






